2 MEN FACING MULTIPLE CHARGES IN DEATHS OF INDIAN FAMILY WHO FROZE **CROSSING INTO US**

The Ahmedabad crime branch has arrested two travel agents, who were allegedly responsible for the death of four members of a family in illegal migration to the US. These four people including two minors had frozen to death while illegally crossing from Canada to America in January 2022. Crime Branch Deputy Commissioner of Police Chaitanya Mandlik told the media on Monday, "On Saturday evening, the crime branch team arrested Bhavesh Patel from Palsana village in Gandhinagar district and Yogesh Patel from Ahmedabad city's Vastrapur area."

They were allegedly involved in illegally sending Jagdish Patel, Vaishali Patel and their children Vihangi and Dharmik to the US. They froze while crossing the Canada-US border near Emerson, on the Canadian side.

The officer said, "Bhavesh and Yogesh sent 11 persons from Kalol and Mehsana to Canada, from where they were asked to cross over to the US illegally. From







INDIAN-AMERICAN SWORN-IN AS OAKLAND CITY COUNCIL MEMBER

Indian-American attorney Janani Ramachandran became the youngest and first gueer woman of colour to take oath as City Council member for Oakland's District 4.

Ramachandran, 30, became the first Oakland City Council candidate to declare her victory in the November 8 mid-term election where she edged past her opponent Nenna Joiner by winning 18,874 in total. "Immensely grateful for all those who believed in me, and helped build our movement. Honoured to have my loved ones by my side as I took the ceremonial oath! Let's get to work," Ramachandran, who took oath in a saree last week, tweeted.

has worked at various legal nonprofits, and served on the board of violence prevention nonprofits across Oakland. Ramachandran, an East Bay native and a former professional musician, serves as a Commissioner on the California Commission for API American Affairs.

Born to immigrant parents from South India, she previously served on the City of Oakland Public Ethics Commission. Prior to law school, Ramachandran worked as a home-visiting case manager for lowincome immigrant mothers.

She later founded a domestic violence advocacy programme across five community health clinics, where she led training for medical staff, supervised advocates, and launched public education campaigns. As a law student, she worked for several legal aid organisations on the intersections of domestic violence, housing, and other social justice causes. At just 16, Ramachandran founded a A graduate of Stanford University and Berkeley Law, Ramachandran nonprofit that built libraries in under-resourced schools in her local community. In her 2021 run for State Assembly, Ramachandran, then a first-time candidate, shocked political experts by advancing to the special election runoff in August, coming out on top amongst a field of previously elected officials, says her website.

DELHI RECORDS EIGHTH COLD WAVE DAY IN JANUARY; TRAINS, FLIGHTS DELAYED DUE TO LOW VISIBILITY

As several parts of north India continues to reel under cold wave, the national capital logged its eighth chilly day in January on Wednesday. So far Delhi has witnessed the most cold wave days in the month in at least 12 days, as per the India Meteorological Department (IMD). The Safdarjung observatory, Delhi's primary weather station, recorded a minimum temperature of 2.6 degrees Celsius. It was 2.4 degrees Celsius on Tuesday and 1.4 degrees on Monday.

In 2020, the national capital recorded seven cold wave days in the month of January, whereas, it did not have any such day last year. The IMD stated that the city recorded an intense coldwave spell from January 5 to 9, the second longest in the month in a decade.

It has also logged over 50 hours of dense fog this month so far, the most since 2019. Meanwhile, the weather department also said that the coldwave conditions would abate from Thursday-Friday under the influence of two western disturbances that are likely to affect the region in quick succession.



UK NURSES STAGE NEW WALKOUT AS STRIKE WAVE INTENSIFIES

Thousands of nurses in Britain walked out Wednesday in a new protest over pay, with no end in sight to a wave of strikes that has piled pressure on the UK's overburdened public health system.

Two 12-hour strikes on Wednesday and Thursday affect about a quarter of hospitals and clinics in England. Emergency care and cancer treatment will continue, but thousands of appointments and procedures are likely to be postponed.

Nurses, ambulance crews, train drivers, airport baggage handlers, border staff, driving instructors, bus drivers, and postal workers have all walked off their jobs in recent months to demand higher pay amid a cost-of-living crisis.

Inflation in the UK hit a 41-year high of 11.1 per cent in October, driven must be maintained during a walkout.

by sharply rising energy and food costs, before easing slightly to 10.5 per cent in December. The nurses' union has been seeking a pay raise of 5 per cent above inflation, though it has said it will accept a lower offer. The Conservative government argues that double-digit public sector pay increases will drive inflation even higher.

"Unaffordable pay hikes will mean cutting patient care and stoking the inflation that would make us all poorer." Health Secretary Steve Barclay wrote in the independent newspaper.

The government also has angered unions by introducing a bill that will make it harder for key workers to strike by setting "minimum safety levels" for firefighters, ambulance services, and railways that

CALIFORNIA FLOOD STORM: 19 DEATHS REPORTED FROM DROWNING, FALLEN TREES; MORE HEAVY RAIN, POWER OUTAGES

The ninth atmospheric river in a three-week series of major winter storms was churning through California on Monday, leaving mountain driving dangerous and the flooding risk high near swollen rivers even as the sun came out in some areas. California is once again being battered by rounds of heavy rain, wind, and snow, causing flood advisories and power disruptions in various areas. Heavy snow fell across the Sierra Nevada and the National Weather Service discouraged travel. Interstate 80, a key highway from the San Francisco Bay Area to Lake Tahoe ski resorts,



reopened with chain requirements after periodic weekend closures because of whiteout conditions. At least 19 deaths have been reported in the state in the past two weeks of storms, many from drowning and fallen trees. "If you must travel, be prepared for dangerous travel conditions, significant travel delays and road closures," the weather service office in Sacramento said on Twitter. The University of California Berkeley Central Sierra Snow Lab tweeted Monday morning that it had recorded 49.6 inches (126 cm) of new snow since Friday.

A NASAMS is a short to medium range ground-based air defence system that protects against drone, missile, and aircraft attack, with a high success rate. Canada's NASAMS donation will help Ukraine strengthen its air defence systems against destructive air attacks on military sites, civilian critical infrastructure, and population centres.

This donation, valued at approximately \$406 million, comes from the additional \$500 million in military aid to Ukraine that Prime Minister Trudeau announced on November 14, 2022. The donation builds on Canada's longstanding military support to Ukraine, including our training mission – Operation UNIFIER, donations of armoured vehicles, artillery, drone cameras, and winter clothing, and ongoing efforts by the Royal Canadian Air Force to transport Ukraine-bound military aid donated by Canada, Allies, and partners. Canada remains committed to providing Ukraine with the military aid that it needs to defend itself from Russia's illegal and unjustifiable attacks, including intensifying Russian air raids.

17-YEAR-OLD TAREN SINGH LAL DIES IN CAR CRASH IN B.C

The force of the crash, which occurred earlier this month, flattened a fence and toppled a tree, the Global News reported.

The Langley Royal Canadian Mounted Police said they were called to the accident site near Fraser Highway and 228th Street. Lal, who was a student of Tamanawis Secondary School in Surrey, died on the spot. His mother told Omni News that she spoke to her son just before the crash, and had asked him to pick up some food on his way home. The family told the channel that they call police every day, with no updates. In a statement to OMNI News, the Langley RCMP said: "Investigators continue to look into all causal factors. These are complex investigations and it is still very early in the investigation." GoFundMe page has been set up to support Lal's family, especially his 12 year-old sister.

The page described Lal as "a loving son, protective older brother, unforgettable friend, and a beloved role model to those around him". He was involved in the community through sports activities and had hoped to join the police force in the future.

ENBRIDGE GAS TEAMS UP WITH BURLINGTON FIRE DEPARTMENT THROUGH SAFE CAOMMUNITY PROJECT ZERO



Enbridge Gas Inc. (Enbridge Gas), the Fire Marshal's Public Fire Safety Council (FMPFSC) and Burlington Fire Department announced they are working together to improve home safety and bring fire and carbon monoxide-related deaths down to zero

The Safe Community Project Zero is a public education campaign that is providing alarms to residents in 50 municipalities across Ontario. Through this project, the Burlington Fire Department has received 438 combination smoke and carbon monoxide alarms.

In 2022, Enbridge Gas invested \$250,000 in Safe Community Project Zero, and over the past 14 years, the program has provided more than 76,000 alarms to Ontario fire departments.

The alarms provided to Burlington will be distributed through a combination of public events, the Alarm Assistance Program and response calls when needed.

When properly installed and maintained, combination smoke and carbon monoxide alarms help provide the early warning to safely escape from a house fire or carbon monoxide exposure. Carbon monoxide is a toxic, odourless gas that is a by-product of incomplete combustion of many types of common fuels.

62-YEAR-OLD BURLINGTON MAN ARRESTED AFTER ALLEGEDLY LURING **CHILDREN ON SOCIAL MEDIA**

The Toronto Police Service would like to make the public aware of an arrest made in a Child Sexual Abuse Material investigation. On December 6, 2022, police became aware of an incident involving the online luring of a child.

It is alleged that:

- * a man was contacting children on various social media platforms for a sexual purpose
- * the man used "MadeInItalyMale" and "Nico Albertini" as usernames on various social media platforms

On Thursday, January 12, 2023, Nicola Colella, 62, of Burlington, was arrested and charged with:

- 1. four counts of Luring a Child Under 16 Years
- 2. Invitation to Sexual Touching
- 3. Sexual Assault Attempt
- 4. Sexual Interference Attempt
- 5. Transmit Sexually Explicit Material to a Person Under 16 Years
- 6. Possession of Child Pornogrophy

SUSPECT OF MISSISSAUGA 'UNPROVOKED' STABBING ARRESTED

Police have taken a suspect into custody allegedly responsible for a stranger stabbing on January 10, 2022, in Mississauga. On Tuesday, January 10, 2022, at approximately 4:40 p.m. Peel Regional Police responded to Hurontario Street and John Street for reports of a stabbing. Officers arrived on the scene and located a 19 year-old-male suffering from a significant stab wound. The suspect was seen fleeing the scene in a southern direction.

The victim was taken to a trauma centre, where he remains in serious but stable condition. The suspect and victim do not appear to be known to each other.

Detectives from the 11 Division Criminal Investigations Bureau quickly identified the man believed to be the suspect as 34year-old David Dytlow of Toronto, and a warrant for his arrest was sought.

On Wednesday, January 11, 2022, at approximately 9:30 a.m., while on an unrelated matter, patrol officers from 11 Division spotted Dytlow at a Mississauga Hospital and swiftly took him into custody without incident.

David Dytlow has been charged with the following Criminal Code Offences:

- * Attempted Murder
- * 3x Fail to Comply with Release Order

At the time of his arrest, Dytlow was on judicial release for several criminal offences, including assault, assault with a weapon, assault causing bodily harm and uttering threats. One of these incidents took place in Peel Region in 2021, where Dytlow is alleged to have stabbed an individual. Dytlow was prohibited from carrying weapons. Dytlow remains in custody pending a bail hearing at the Ontario Court of Justice in Brampton.



'TEAM CANADA' TRADE MISSION TO VISIT JAPAN IN OCTOBER: PM TRUDEAU

The leaders discussed strengthening bilateral trade, investment, and innovation, and reinforcing supply chain resilience and economic security to create good middle-class jobs and new opportunities for our businesses. They talked about expanding cooperation in areas such as agriculture and agri-food, energy, critical minerals, and emerging technologies. They also discussed their shared commitment to maintain and build on the Comprehensive and Progressive Agreement for Trans-Pacific Partnership's (CPTPP) high standards, which facilitate growth and job creation for both countries.

They announced a planned incoming mission to Canada in early spring of 2023 welcoming Japanese companies seeking new partners and investment opportunities in Canada related to zero-emission vehicles and batteries. They also announced Canada's plan to undertake a Team Canada trade mission to Japan in October as part of Canada's Indo-Pacific Strategy. The prime ministers discussed Japan's priorities for its upcoming G7 Presidency and the importance of continued G7 coordination to uphold the rules-based international system, in light of new and emerging global challenges. They will maintain close cooperation between G7 members to denounce Russia's unjustifiable and illegal aggression against Ukraine, and to protect Ukraine's sovereignty and territorial integrity. Prime Minister Trudeau raised the importance of maintaining work on the G7's Gender Equality Advisory Council.


The leaders shared concerns about the wider global impacts of Russia's Hiroshima, in May 2023.

military aggression against Ukraine, notably for the Global South, with shortages and rising prices of food, fuel, and fertilizer. They committed to working together, including with G7 partners, to find practical ways to mitigate these impacts, particularly for the most vulnerable people, and to address their significant implications for the Indo-Pacific region. Prime Minister Trudeau also raised the importance of G7 members engaging on issues around the world, including anti-regime protests in Iran and the humanitarian and security crisis in Haiti.

Prime Minister Kishida shared details of Japan's new National Security Strategy. The two leaders discussed their concerns about China's actions in the region and agreed on the importance of a coordinated approach to security in the Indo-Pacific. They talked about their deep concern with the threat of North Korea's nuclear weapons and ballistic missile programs and reiterated their support for a complete, verified, and irreversible dismantlement of North Korea's nuclear weapons. The prime ministers reaffirmed their commitment to the multinational effort to help monitor United Nations sanctions against North Korea, to which Canada is contributing through Operation NEON. The prime ministers also hosted Canadian and Japanese business leaders for a luncheon, to share their vision for a stronger trade, investment, and innovation partnership. They highlighted the growing and exciting business potential between the two countries. Prime Minister Trudeau and Prime Minister Kishida agreed to remain in close contact as Japan prepares to host the G7 Summit in

As the government significantly expands the number of surgeries being done through community surgical and diagnostic centres, it will do so with measures in place to protect the stability of health human resources at public hospitals, including requiring new facilities to provide detailed staffing plans as part of their application and requiring a number of physicians at these centres to have active privileges at their local hospital. "When it comes to your health, the status quo is no longer acceptable," said Premier Doug Ford. "Our government is taking bold action to reduce wait times for surgeries, all while ensuring Ontarians use their OHIP card to get the care they need, never their credit card." Community surgical and diagnostic centres have been valuable partners in responding to the pandemic and addressing the pandemic-related backlog in surgeries. Increasing community delivery of surgeries has proven to increase patient and provider satisfaction and reduces the risk of a rescheduled appointment. Surgeries performed at these centres will be publicly-funded.

Ontario has a three-step plan that better integrates and uses these state-of-the-art facilities to speed up how quickly people are able to get surgeries and procedures using their health card.

Step One: Ontario is urgently tackling the existing backlog for cataract surgeries, which has one of the longest waits for procedures. New partnerships with community surgical and diagnostic centres in Windsor, Kitchener-Waterloo and Ottawa will add 14,000 additional cataract surgeries that will be performed each year. This number represents up to 25% of the province's current cataract waitlist, and accounts for the estimated COVID-related backlog of cataract surgeries. These centres will perform the 14,000 additional surgeries with existing health human resources.

Ontario is also investing more than \$18 million in existing centres to cover care for thousands of patients, including more than 49,000 hours of MRI and CT scans, 4,800 cataract surgeries, 900 other ophthalmic surgeries, 1,000 minimally invasive gynecological surgeries and 2,845 plastic surgeries such as hand soft tissue repair. Surgical wait lists are anticipated to return to pre-pandemic levels by March 2023, barring operational issues.

Step Two: To further reduce wait times, Ontario is expanding the scope of community surgical and diagnostic centres to address regional needs with a continued focus on cataracts, as well as MRI and CT imaging and colonoscopy and endoscopy procedures. To start as early as 2023, these procedures will be non-urgent, low-risk and minimally invasive and, in addition to shortening wait times, will allow hospitals to focus their efforts and resources on more complex and high-risk surgeries.

'WE NEED JUSTICE': WIFE OF EDMONTON MAN, BARINDER SINGH SHOT DEAD ON NEW YEAR'S DAY SEEKS JUSTICE



The wife of a 51-year-old Sikh man, who was shot dead when intruders broke into his Mill Woods house in Canada on New Year, has said that she needs swift justice for her husband. Barinder Singh, who hails from Punjab and had moved to Edmonton in 2019 along with family, was asleep when intruders broke into his house at Mill Woods Road and started firing, the Global News reported.

Police responded to a disturbance around 2.45 a.m., and arrived at the complex in the Pollard Meadows neighbourhood to find an injured 51-year-old man lying in a pool of blood.

"It's all like a nightmare for us," a shattered Jasjeet Kaur, wife of Singh, told Global News.

Singh was taken to a hospital where he succumbed to his injuries. The autopsy revealed that he died from gunshot wounds and the medical examiner said that the manner of death was a homicide. "We need justice. I just want to know who did this. I need to know. Whya Why my family was the target? And it was not just him -- it was the whole family," Jasjeet Kaur told the Canadian news channel. "I want the culprits. I want to know the reason why it happened."

A GoFundMe page set up for Singh described him as an "honest, family man who worked hard to provide for his family".

"(He was) a devoted son, a good brother and a caring father -- he kept us going through good times and tough times. Through his work, he supported my grandparents in Punjab, while providing for us in Delhi, India," the page quoted his two daughters as saying. Police said it is still working to establish a motive for this violent crime. So far, the homicide unit has found a burnt-out white Dodge Ram truck in the nearby Laurel neighbourhood, which they think is connected to the crime.

They are looking for home security and dashcam footage in the area where the burned-out truck was located.

UKRAINE SETS TO GET 3 BN EUROS FROM EU THIS WEEK: PM



Ukraine is set to receive 3 billion euros (about \$3.25 billion) from the European Union (EU) this week as a part of fresh financial aid, Ukrainian Prime Minister Denys Shmyhal has said.

Shmyhal wrote on Telegram that Ukraine and the EU signed a memorandum of understanding (MoU) for the macro-financial program for Kiev worth 18 billion euros (about \$19.5 billion), Xinhua news agency reported.

The funds will help Ukraine to maintain macroeconomic stability and cover all critical expenses this year amid the ongoing war with Russia, Shmyhal said.

In 2022, Ukraine received \$32.1 billion in international aid, with \$8 billion of the funds coming from the EU, according to the country's central bank.

BIDEN'S LEGAL TROUBLES

ecent revelations that classified documents going back to US President Joe Bidens term as vice-president have been found in his private office and at his home, may become a political -- and possibly legal -- liability for the president.

President Biden's own handling of classified materials is now under scrutiny given the revelations that documents were stored at his private office and home.

In his defence Biden said he was "surprised" to learn of the discovery of the records. Earlier, he had branded his predecessor, Donald Trump, "irresponsible" for storing classified documents at his Mar-a-Lago estate in Florida.

BIDEN'S HEADACHE

The latest imbroglio could become a headache for Biden; as first, the US Congress may investigate this oversight. The Republican Party feels emboldened by its majority in the House of Representative and it may issue a subpoena to Biden. Republican members of the Congress are already gearing up for a series of investigations into the Biden family's and his son Hunter's finances.

Congress Speaker Kevin McCarthy said last week that he think that the Congress has to investigate this.

Meanwhile, letters have been sent to Attorney General Merrick Garland and Avril Haines, director of national intelligence, by Representative Mike Turner, the top Republican on the House Intelligence Committee, requesting a classified briefing on 23 January on the latest detection.

In his letter Turner wrote that the presence of classified information at the two locations "could implicate the president in the mishandling, potential misuse and exposure of classified information."

Meanwhile, the US Attorney General Merrick Garland has appointed two different special counsels to independently investigate the handling of classified records by former Republican president Donald Trump and his Democratic successor, President Joe Biden.

Trump is being investigated by Jack Smith, a war crimes prosecutor, on whether he or his associates improperly retained classified records at his Florida estate after he left office in 2021 and then tried to obstruct a federal investigation. Former

US Attorney Robert Hur has been appointed by Garland to investigate the removal and retention of classified records from Biden's time as vicepresident, and their discovery at two locations.

SIMILARITIES BETWEEN BIDEN AND TRUMP'S CASES

According to the US, laws neither Trump nor Biden should have had any classified material in their possession. The records from each administration are supposed to be turned over to the legal custody of the U.S. National Archives, during a presidential transition period.

In addition, it is unlawful to knowingly or wilfully remove or retain classified documents. Failure to properly store and secure classified material poses risks to national security if it should fall into the wrong hands.

On the recovery, Biden has said he was surprised to learn he had classified information in his possession. While, Trump has said on social media,

without providing evidence, that he de-classified the records, though his attorneys have declined to repeat that assertion in court filings.

The materials in question date back to when Biden was former President Barack Obama's Vice President from 2009 to 2017, and when Trump was President from 2017 to 2021.

Legal experts say there are unambiguous contrasts between the two cases. In Trump's case, the National Archives tried for more than a year after Trump left office to retrieve all of the records he retained, without success. When Trump finally returned 15 boxes of documents in January 2022, Archives officials discovered they contained classified materials. The matter was referred to the Justice Department, which issued a grand jury subpoena last year in May seeking the return of all classified records. Investigators then visited Trump's home, where his attorneys handed over more material and asserted there were no more documents on the premises. That turned out to be false. Additional evidence collected by the FBI, including surveillance footage from the Mar-a-Lago estate, prompted agents to seek court approval to execute a search warrant on 8 August 2022, amid concerns over possible obstruction. The FBI recovered an additional 13,000 documents, about 100 of which were marked as classified. In Biden's case. Garland said the president's attorneys informed the Archives and the Justice Department in November 2022 that they had discovered fewer than a dozen classified files inside a closet at the Penn Biden Centre think-tank in Washington D.C. earlier that month.

After the discovery, the attorneys continued to conduct additional searches at Biden's homes in Wilmington and Rehoboth Beach, Delaware, where more documents were found in both December 2022 and January 2023. All were turned over to the authorities.

LEGAL PERILS FOR BIDEN AND TRUMP

The US law is very clear that it is a crime only if the retention and removal of classified records is intentional. Prosecutors typically won't pursue charges for the accidental retention of classified records, but if there is evidence of possible obstruction of justice, that could change things.

On their part legal experts say, Trump faces considerably more legal liability than Biden. To date, there has been no suggestion by the Justice Department that Biden knowingly retained the records or refused to return them to the government.

Also, as the current president, Biden is unlikely to face prosecution. The Justice Department has not changed its long-standing policy that a sitting president cannot be indicted.

The same policy helped insulate Trump when he was president and under investigation by the then Special Counsel Robert Mueller. In that case, Mueller declined to determine whether Trump had obstructed his investigation into possible ties between Russia and Trump's 2016 election campaign because of the department's policy.

However, from a political perspective, questions about Biden's handling of classified documents could not come at a more inconvenient time for him and his party.

Biden ended 2022 with a number of late-year victories, his approval ratings had started to tick back up, and he is expected to announce in the coming weeks that he will run for a second term in 2024.

The documents debacle provides the Republicans with a new line of attack to use against him during the upcoming campaign and makes it more difficult for him to turn the issue against Trump, who has already announced he will seek the Republican nomination for president.

The collision claimed the lives of two females and four males who range in age from 20-23. PEEL REGIONAL POLICE ANNOUNCES SAFE CENTRE RESPONSE TEAM TO ADDRESS GENDER-BASED VIOLENCE

Victims of intimate partner violence in Peel Region will now receive improved up-front care and referrals with the launch of the Safe Centre Response Teams.

This pilot program is developed through collaboration between Safe Centre of Peel and Peel Regional Police. Two response teams comprised of a mobile support worker with experience in gender-based violence and a specially trained police constable, will provide appropriate, timely and complex care and support in intimate partner incidents. This initial response will ensure victim safety, early intervention and supporting individuals and families to receive the help they may need. The key function of the Safe Centre Response Team is to:

* Connect families with existing community services to help stabilize the family situation over the short term and help increase their resiliency over the extended period.

* Help bridge the gap between identifying risk factors and direct intervention, thereby reducing the number of families looking for help being overlooked.

* Ensure a range of existing prevention and intervention services are provided in a timely manner, to reduce the risk of harm and increase the safety of family members.

In 2021, 17,000 calls for service were related to Family and Intimate Partner Violence in Peel Region, which translates to an average of 45 disputes are reported per day - or about two every hour. Between 2016 and 2021, the rate of intimate partner violence increased by 3.5 percent.

Safe Centre Response Teams have been created in response to this significant public health and safety issue.

SCRT teams will rotate on 12-hour shifts and be dispatched to non-criminal, non-violent calls focused on intimate partner violence and are a part of the continuing evolution of the Community Safety and Well-Being (CSWB) plan.

"The Safe Centre Response team is yet another new pathway in service delivery for our community. This non-traditional response will provide compassionate, upfront care, referrals and resources for people in need and address intimate partner incidents. These teams will bridge the gap that currently exists between initial in-crisis response and the provision of complex care typically provided post-incident by community human service providers. MY IDEOLOGY DOESN'T MATCH WITH VARUN GANDHI'S: RAHUL GANDHI

Former Congress President Rahul Gandhi, while responding to a question on BJP leader Varun Gandhi, said on Tuesday that his ideology doesn't match with the latter, adding that he'd rather be beheaded than go to the office of the Rashtriya Swayamsevak Sangh (RSS).

Commenting on his estranged cousin, Rahul Gandhi said, "He (Varun Gandhi) is in the BJP. If he walks into the Bharat Jodo Yatra, he might be in a problem. My ideology does not match his ideology. My family has an ideology, we have different ways of thinking... But Varun has adopted the RSS ideology, which is not acceptable."

"I can meet him, I can hug him, but I cannot accept the RSS ideology. There is a clash between the two ideologies. Many years ago, Varun had told me that RSS is also doing good work. I had told him then that 'you have not studied the history of the family; had you did, you would not have said this'," Rahul Gandhi said.



DELHI HIT-AND-DRAG CASE: COURT GRANTS BAIL TO ONE ACCUSED

A Delhi court on Tuesday granted bail to Ashutosh Bhardwaj, an accused in the infamous hit and drag case, in which a 20-year-old woman died a painful death after being dragged by a car for about 12 km in the early hours of January 1.

"He is admitted to bail on furnishing bail bond of Rs 50,000," the order said, adding that Bhardwaj's role came after the crime was committed. A detailed order in the matter is awaited.

On January 16, Additional Sessions Judge Susheel Bala Dagar reserved its order on Bhardwaj's bail plea.

Delhi Police had opposed the bail plea, contending that it is a serious case and they are in the process of invoking Section 302 (murder). On January 12, the court had dismissed Bhardwaj's bail plea.

Metropolitan Magistrate Sanva Dalal had said that considering the gravity of the offence, the fact that the investigation is at an initial stage, and the offences alleged against the accused are exclusively triable by the sessions court, this court is not inclined to grant bail. By claiming that co-accused Deepak was driving the car, Bharadwaj allegedly deceived the inquiry, according to Additional Public Prosecutor Atul Srivastava.

"There is a thin line of difference between having knowledge and subsequently having knowledge. We are investigating the case... When he (Bharadwaj) was a free man, he misled the investigation. He can mislead the probe again in future," Srivastava said.

As per sources, Bhardwaj had talks with the five accused persons and as co-accused Amit did not have a driving licence, another coaccused Deepak was told to tell the police that he was in the driver's seat at the time of the incident.

Counsel representing Bhardwaj had moved the plea on January 9 Deepak Khanna, Amit Khanna, Krishan, Mitthun and Manoj Mittal.

AI 'PEE GATE': CREW REPORT SUGGESTS WOMAN INSTIGATED BY CO-PASSENGER

The report of the Air India crew on the urination incident on a New York-New Delhi flight, states that there might be potential instigation by co-passenger S. Bhattacharjee, who was seated on seat 8A, in front of the elderly woman victim (on 9A), and next to accused Shankar Mishra, who was on 8C. The crew members' four-page report stated that the complainant may have been instigated by a co-passenger and that her subsequent behaviour casts a doubt about her "intent and integrity" while Bhattacharjee had requested an upgrade to first class on boarding, but was turned down, according to media reports.

There is even some contradiction in the statements made by the complainant and the passenger on 9C, sitting right next to the complainant. The crew members have stated that she came to the galley and said that she required cleaning as a co-passenger had urinated on her and her clothes were wet. She was provided with a towel, slipper, socks, antiseptic (Savlon) and even nightwear was also given by the airline. "Her seat, the area around, her shoes, and the bags of both the passengers were sanitised," stated the report. However, it said that the woman demanded compensation for her soiled articles and spoke about filing a police complaint, though the crew promised her all help. They also shifted her to a new seat though she had not demanded this.

Recently after accused Shankar Mishra claimed that the complainant had soiled her own seat, the latter rubbished the allegation saying that it was "completely false and concocted". "The said allegation is also in complete contradiction and a complete volte-face of the statements and the pleaded case of the accused in his bail application," she said.

The victim said that her intention has all along been of ensuring that institutional changes are made so that no individual has to go through the "horrendous experience" she went through.

"Instead of being remorseful for the utterly disgusting act committed by him, he has adopted a campaign of spreading misinformation and falsities with the intent of further harassing the victim," she further said.

On January 13, Mishra told the court that he is not the accused. "There must be someone else who peed or it must be her who urinated," he had said. He further claimed that the woman was suffering from some prostate-related disease.

"Her seat was such that it could only be accessed from behind and in any case, the urine could not reach the seat's front area. Also, the person sitting behind the complainant did not make any such complaint," he had said. On January 11, Mishra's counsel had contended that his actions, while obscene, were not intended to sexually harass the victim. Mishra has been booked under Sections 510 (misconduct in public by a drunken person), 509 (insulting the modesty of a woman), 294 (sings, recites or utters any obscene song, ballad or words, in or near any public place), and 354 (intending to outrage modesty) of the IPC as well as a section of the Aircraft Rules Act in a case registered at the IGI Airport police station.

THREE PAKISTANIS ARRESTED IN NEPAL FOR KIDNAPPING COMPATRIOT



Three Pakistani nationals have been arrested by Nepal Police in Kathmandu on the charge of kidnapping and holding their compatriot hostage for ransom after luring him with a promise of a lucrative job in Canada, local police authorities said.

The arrested Pakistani nationals have been identified as Mohamad Rashid, 30, Mohamad Asif, 35, and Mohamad Fida Hussain, 35, according to the Kathmandu Valley Crime Investigation Office under the Nepal Police.

Police investigation has revealed that the three Pakistani nationals invited their fellow countryman Mohamad Sami Khan to Kathmandu giving a false hope that the visa process to Canada would be much easier from Nepal than from Pakistan.

Accordingly, Khan came to Nepal on a tourist visa on January 7. Then, the Pakistanis took him to a hotel in Thamel, downtown Kathmandu. The very next day, on January 8, they took him to Budhanilkantha area, held him hostage at a rented house and demanded a ransom of 2.6 million Nepali rupees.

The kidnappers asked the victim to telephone his brother in Pakistan so that they can get the money immediately.

After receiving the ransom amount, the kidnapper left Sami Khan halfway at Sinamangal area in Kathmandu and ran away. Acting on a complaint filed by the victim at Tourist Police in Kathmandu, a joint team of police from the District Police Range, Kathmandu and Kathmandu Valley Crime Investigation Office, launched a massive search operation across the Nepali capital. Three days after the kidnapping, local police authorities nabbed all the Pakistani nationals from Budhanilkantha area.

Krishna Prasad Koirala, a spokesperson for the Kathmandu Valley Crime Investigation Office, said that the Pakistanis have been charged for abduction under the Criminal Code Act (2017)

"They will be sent to jail once our investigation is over," Koirala told India Narrative.

This is not the first time that Pakistani nationals are found to have been involved in criminal activities in Nepal. Mostly, they are arrested for being involved in fake Indian currency notes in Nepal.

CBI FILES FRESH FIR IN CHINTELS PARADISO BUILDING COLLAPSE

Nearly a year after a tower collapsed in the Chintels Paradiso residential apartment complex in Gurugram that claimed two lives, the Central Bureau of Investigation (CBI) on Tuesday lodged a fresh FIR in connection with the case.

Two women were killed when the floor of a sixth-floor apartment of Tower D at Chintels Paradiso in Sector 109 came down on February 10 last year, triggering the collapse of roofs and floors directly under it, till the first floor, Luckily, the flats between the sixth and first floor were vacant, otherwise there could have been more casualties.

The CBI filed the fresh FIR against the MD of Chintel Group after the Haryana government directed the agency to look into the matter. Initially, a case was lodged under Sections 304A and 34 of the Indian Penal Code at the Bajghera police station. Now, the central probe agency has added Sections 304 (II), 338, 427, 465, 468, 471, and 120-B of the IPC and Sections 10 and 12 of the Haryana Development and Regulation of Urban Areas Act in the matter. Rajesh Bhardwaj, a resident of Chintels Paradiso, had first lodged

a complaint with the local police in connection with the ceiling ceiling collapse. Rajesh's wife Ekta Bhardwaj (31) got trapped under the debris and later succumbed to her injuries. Rajesh had alleged that the incident happened due to the

Group, Ashok Saloman, and the contractor. **DELHI HC ADJOURNS HEARING ON** SHARJEEL IMAM'S BAIL PLEAS

The Delhi High Court on Tuesday adjourned, to January 30, the hearing of JNU student Sharjeel Imam's two different pleas seeking regular bail and interim bail in connection with a 2020 riots case involving allegations of sedition.

A division bench of Justices Siddharth Mridul and Talwant Singh was dealing with a petition seeking interim bail in a case where he was charged under Section 124A (sedition) of the Indian Penal Code. Counsel for Imam said that he has been granted bail in another case where sedition charges were present.

However, the court said that as the pleas are based on same FIR, they will have to hear them together as same issues cannot be agitated more than once. The bench said: "Two of your appeals (against denial of regular bail and interim bail by trial court) are pending for the same FIR. We will hear them together; you can't agitate same issue more than once. It can't be heard like this." Imam's counsel informed the court that his regular bail plea is

scheduled for hearing in April and he has sought interim bail until the Suprene Court decides the constitutional validity of offence of sedition. The court observed that the apex court has not ordered the release of all those charged with sedition. Morever, Imam, in this case has been been charged with not just sedition but more offences, it noted. "The end result of both (pleas) is the same. You can't have it both ways. We have two bail applications before us today. We can't hear you today and then later. We will hear you together. Nowhere has Supreme Court said that you have to be enlarged on bail," the court said. Imam's counsel also made a point that his client's plea regarding the framing of charges in the matter is also pending. The court listed the matter for hearing on January 30 instead of April.



CHINA'S POPULATION DIPS FOR 1ST TIME IN 6 DECADES, INDIA TO TAKE TOP SPOT

China's population has declined for the first time since 1961 as the important, with implications for potential growth and domestic national birth rate fell to a record low of 6.77 births for every 1,000 people last year, media reports said on Tuesday.

With China's population decline, India is projected to overtake China as the world's most populous country this year, according to the United Nations. The South China Morning Post reported that the national birth rate for 2022 fell to a record low in China.

Deaths outnumbered births in China as its overall population plummeted by 850.000 people - to 1.4118 billion in 2022, down from 1.4126 billion a year earlier, according to the National Bureau of Statistics (NBS).

The national death rate was 7.37 per thousand last year, putting the national growth rate at negative 0.6 per thousand people in the country currently going through a Covid crisis that killed nearly 60,000 people in about a month's time.

"China's population declined the first time since 1961. The population will likely trend down from here in the coming years. This is very

demand," Zhang Zhiwei, chief economist at Pinpoint Asset Management, was quoted as saying.

The report said that the population growth had been slowing since 2016. In 2021, China eased birth restrictions to allow couples to have three children, entitling them to childcare and other benefits. Shenzhen is among the latest cities to incentivise childbirth via cash handouts. The UN also expects China's population to drop to 1.313 billion by 2050 and fall below 800 million by 2100.

However, as the number of new births fall, China's ageing crisis is deepening. The country had 280.04 million people aged over 60 at the end of 2022, up from 267.36 million people or 18.9 per cent of the population at the end of 2021. China's working-age population -- those between 16 and 59 years old -- stood at 875.56 million at the end of 2022, representing 62 per cent of the population, down from 62.5 per cent a year earlier. Without proper change, the ageing population will have a long-term effect on economic growth, said the report.

SIKH FAMILY ALLEGES RACIAL DISCRIMINATION AT WINDSOR CASTLE, THREATENS LEGAL ACTION



FORMER SCBA PRESIDENT SHOT DEAD INSIDE PESHAWAR HIGH COURT

In a shocking incident of targeted killing, former president of the Supreme brutal murder of Latif Afridi has been widely Court Bar Association (SCBA) and senior lawyer Latif Afridi was shot dead inside the Peshawar High Court (PHC) bar room.

As per details, the shooter entered the bar room and opened fire, hitting Latif Afridi with at least six bullets. Latif Afridi was rushed to the Lady Reading Hospital, where he succumbed to his injuries during treatment. "Latif Afridi was sitting with the other lawvers in the PHC bar room when a gunman opened fire at him. The police have arrested the gunman who has been identified as Adnan Afridi. The attacker is related to Latif Afridi," said Senior Superintendent of Police, Kashif Abbasi. "A small weapon, an identity card and a student card have been recovered from the attacker. We suspect that the attack was carried out because of personal enmity," Abbasi said. The killing of Latif Afridi is not a first in his family. His cousin Aftab Afridi, who was an anti-terrorism judge in Swat, Khyber Pukhtunkhwa (KP), was also killed in a firing incident in 2022. In that case as well, family members were held accused, who were later acquitted by the anti-terrorism court in Swabi. Monday's incident has sent shockwaves among the lawyer community, who have expressed serious concerns over the security arrangements in the Peshawar High Court. The Peshawar High Court Bar Association (PHCBA) has termed the incident as a major security lapse, raising questions as to how a man with a weapon could reach the bar room, located deep inside the high court building. The

condemned, with senior politicians, including the Prime Minister, expressing their grief over the incident. "I pray that the bereaved family bears this loss with fortitude. The worsening law and order situation in Khyber Pukhtunkhwa is alarming. The provincial government should take immediate measures in this regard." said Prime Minister Shehbaz Sharif. Former

Former SCBA president Ahsan Bhoon termed Latif Afridi as an upright man since his student days who faced tough times during Ayub Khan's martial law. "He was part of the students' union in his young days and later he joined the ANP (Awami National Party). Afridi had also suffered tough times during martial law during ex-dictator Ayub Khan's tenure. Afridi was a strong advocate of democracy. He resisted all anti-democratic forces throughout his life," said Bhoon. In view of the tragic incident, the Lahore High Court Bar Association (LHCBA) and the Khyber Pukhtunkhwa Bar Council (KPBC) have announced a strike on Tuesday. The lawyers' associations have called on the government to ensure protection of lawyers and judges, who are unsafe even inside the court and bar rooms.

INDIAN STUDENT FROM PUNJAB DIES IN AUSTRALIA CAR CRASH

A 21 year-old student, who had moved to Australia eight months back from Punjab's Ferozepur, died on the spot after his car collided with a truck in Canberra, a media report said.

Kunal Chopra was returning from work when his Hyundai Getz collided head-on with a concrete pumping truck on William Hovell Drive

last week, SBS Punjabi, a multicultural and multilingual broadcaster in Australia, reported. The Australian Capital Territory Ambulance Service paramedics declared Chopra dead on the scene.

The driver of the concrete pumping truck was taken to a hospital for mandatory drug and alcohol testing, according to the report. William Hovell Drive was closed for several hours after the crash.

Preliminary investigations revealed that the Hyundai crossed to the wrong side of the road into the path of the city-bound truck. Acting Inspector for Road Policing Travis Mills told SBS that the major collisions team was continuing to investigate the incident and will

prepare a report. Chopra was living with his cousin Honey Malhotra in Canberra.

"We are heartbroken, and his family back home is shattered and inconsolable," Malhotra told SBS Punjabi, adding that they are making arrangements to send Chopra's mortal remains to his family back in India.

IRAN TO GET RUSSIAN SU-35 FIGHTERS SOON

Iran will take delivery of a number of Su-35 fighter jets from Russia in the early days of the next Iranian year, which will start on March 21, an Iranian lawmaker has said.

In an interview published by Tasnim news agency, Shahriar Heydari, a member of the Iranian Parliament's National Security and Foreign Policy Committee, revealed that Iran had previously ordered the fighter jets, Xinhua news agency reported.

The lawmaker noted that Iran has also ordered a number of defense and missile systems as well as helicopters, most of which will be soon delivered by Russia. Iranian Foreign Ministry spokesman Nasser Kanaani said in December 2022 that cooperation between Tehran and Moscow in different areas, particularly the defense sector, is not against any third country. Ukraine and some Western countries have recently accused Iran of exporting suicide drones to Russia for use in the ongoing conflict in Ukraine. Iran has admitted to supplying Russia with a small number of drones in the months before the Ukraine conflict, but has denied supplying Moscow with unmanned aerial vehicles for use against Kiev.

INDIAN-AMERICAN TAKES OATH AS KANSAS STATE SENATOR



Indian-American city commissioner Usha Reddi took oath as senator in the US state of Kansas, replacing current Manhattan Senator Tom Hawk, who announced his retirement last month. Reddi, who has served on the Manhattan City Commission since 2013, was appointed by Democratic precinct leaders in Riley, Geary and Clay counties.

"I was sworn in this afternoon as State Senator for District 22. It was great to have my family join me today. I look forward to representing you," Reddi tweeted after taking oath on Thursday. Reddi will complete the remainder of Senator Hawk's term, which expires in 2025.

"Thank you, Senator Tom Hawk for your dedicated service. You lead with sincere love for community and built strong relationships along the way. Enjoy your well-deserved retirement," Reddi wrote in a tweet.

She was first elected to the Manhattan City Commission for a four-year term in April 2013 and re-elected in 2017 and 2021. She served as Mayor in 2016-2017 and in 2020.

Her family immigrated from India to the US in 1973, when she was eight years-old.

She was raised in Columbus, Ohio, along with her two brothers. "Many of us have known Usha in her capacity as a community leader for years now, and we look forward to bringing her into the fold when she joins us as a legislative colleague next week," Senate Democratic Leader Dinah Sykes told ksn.com.

Sykes added that she is eager to use Reddi's strengths in the Legislature to help move Kansas forward Manhattan resident for more than 28 years.

Reddi earned a Bachelor of Arts degree in Developmental Psychology from Ohio State University, a Bachelor of Science degree in Elementary Education and a Master of Science in Educational Leadership from Kansas State University.

She taught 1st grade for over 10 years and received the Elected Women of Excellence Award from the National Foundation of Women Legislators in 2020.

ITALY'S MOST-WANTED MAFIA BOSS ARRESTED AFTER 30 YEARS ON THE RUN

After 30 years on the run, notorious mafia boss Matteo Messina Denaro was arrested in Sicily, the Italian authorities have said. He was captured by the police at a private health clinic where he was receiving treatment in Sicilian capital Palermo, Xinhua news agency reported.

Messina Denaro, 60, is considered the top boss of the Cosa Nostra crime syndicate, one of Italy's three most powerful mafia groups (along with 'Ndrangheta and Camorra).

He had been on the run since 1993. A year later, the first international arrest warrant was issued against him.

He was sentenced in absentia to a life term for his role in several murders, including those of top anti-mafia magistrates Giovanni Falcone and Paolo Borsellino in 1993 and of an 11-

Currently on an official visit to Turkey, Italy's Interior Minister Matteo Piantedosi expressed his "great satisfaction" at Messina Denaro's arrest.

"This is an extraordinary day for the state and for all those who have always been fighting against the crime syndicates," Piantedosi said in a statement.

Italy's Prime Minister Giorgia Meloni said she would travel to Palermo to congratulate the prosecutors and the police forces.

NEPAL PLANE CRASH VICTIM LOST PILOT HUSBAND IN ANOTHER CRASH 17 YEARS AGO

A woman who was killed in the Yeti Airlines plane crash in Nepal had lost her pilot husband also in a tragic plane crash 17 years ago. The victim, Manju Khatiwada, 44, was the co-pilot of the ill-fated plane that crashed on Sunday in the western city of Pokhara. He husband, Dipak Pokharel died in 2006 during a plane crash in the Jumla district.


According to the Kantipur national daily, after the death of her pilot husband, her father, Govinda was planning to send her to India for nursing study but she denied it and went to the US to undertake a pilot course. She was supposed to be promoted to the rank of pilot after undertaking a few more flights.

In order to become a pilot, one needs at least 100 hours of flying experience.

Manju had successfully landed in almost all of Nepal's airports earlier. After one more successful landing, she was about to get a chief pilot's license on Sunday.

She is survived by her daughter. Dipak Pokharel had died when a 9N AEQ aircraft of Yeti Airlines en route from Nepalgunj to Jumla via Surkhet crashed, killing six passengers and four crew members. The plane that crashed on Sunday was piloted by Senior Captain Kamal KC. She died while fulfilling the dream of her first husband, Santosh Timilsina, manju's second husband, told the media in Biratnagar, an eastern town of Nepal where she was born and brought up.

WITH QUARTERFINALS IN SIGHT, INDIA SEEK BIG WIN AGAINST WALES

India, who have yet to lose a match, will look to improve their performance in penalty corners as they aim to secure a big win against Wales, who are at the bottom of the standings and participating for the first time. This will secure India's direct entry into the quarterfinals of the FIH Men's Hockey World Cup, which is taking place on Thursday.

India and England are on four points each after two matches with the latter ahead on goal difference, plus five as against the hosts' plus two. India, though, will have the advantage of knowing what to do before their match as they play after England's game against Spain on Thursday. If England loses or draws against Spain, there will be no headache for India as they just need to beat Wales by any margin to top Pool D, considered the group of death, and qualify directly for the quarter-finals. If England beat Spain, then India will need to defeat Wales by at least five goals. The number of goals India need to score will keep on increasing depending on England's victory margin. If two teams are on equal points and have the same number of wins, the rankings in the pool stage are decided based on goal difference.In any case, India will not be knocked out of the tournament as they will finish second if they beat Wales -- a task they are expected to accomplish. If India finish second in Pool D, they will play the third-place team in Pool C, which could be either New Zealand or Malaysia in the 'crossover' round.

India had beaten Spain 2-0 before drawing England 0-0, both matches played at the new Birsa Munda Stadium in Rourkela. They are going to play at the Kalinga Stadium for the first time in this World Cup. The winning team in each of the four pools qualifies directly for the quarter-finals. The second and third-placed finishers in each pool will feature in crossover matches. A second-place finisher of a pool will play a third-place side of another pool and the winning team will face a pool topper in the quarter-finals. If India top Pool D and qualify directly for the quarter-finals, they will play one match less and that may keep them fresh for the last-eight stage. "If we top our pool, we will play one match less and that will be good for us. We will try to play our best and play our normal game and execute our plans," said midfielder Manpreet Singh, who had led India to a historic bronze at the Tokyo Olympics in 2021. The main concern for India is their rate of penalty-corner conversion. They have got nine penalty corners

so far but have not scored even once from them directly, though Amit Rohidas found the target against Spain after captain Harmanpreet Singh's drag-flick rebounded off an opponent's stick. Drag-flicker Harmanpreet has been the country's top scorer in almost all tournaments in recent times, including the historic bronze-winning campaign in the Tokyo Olympics, but he has been struggling to find the target in this showpiece event. It will be easier for India to win by a big margin if Harmanpreet starts firing as his side is expected to get penalty corners in plenty against Wales. "I hope to start scoring goals from penalty corners in the next match," Harmanpreet had said after the England match. India will also need to convert field chances as they missed several scoring opportunities against England." "Missed opportunities and we next (against Wales) have to try and do better inside the opposition circle," head coach Graham Reid said. India were also dealt a blow after midfielder Hardik Singh injured his hamstring towards the end of the England match. He will be an unlikely starter in Thursday's match against Wales, though he is expected to recover in time for the quarter-final or the crossover stage. No doubt, Hardik will be missed but his absence is unlikely to affect India's chances against Wales, ranked 14th in the world as against the hosts' fifth as per the latest rankings. The likes of Vivek Sagar Prasad can fill in for Hardik. Wales will only be playing to maintain their dignity as they have very little chance of advancing to the next round due to their previous defeats against England (0-5) and Spain (1-5). Even if they were to win against India, which is not likely, and Spain were to beat England, Wales may not qualify for the crossover stage because of their negative goal difference of nine.

'NEW SELECTION COMMITTEE WANTS TO GIVE MORE OPPORTUNITIES TO YOUNGER PLAYERS': GAVASKAR ON KOHLI, ROHIT'S ABSENCE FROM T20IS

India skipper Rohit Sharma and former captain Virat Kohli's continued absence from T20 cricket has raised a number of concerns, one of which is whether or not they would return to the shortest format of the game. Speaking about the new selection committee's plans and Virat Kohli and Rohit Sharma's role in the 50-over World Cup, former batting great Sunil Gavaskar told India Today that the batters have been rested to prepare for the Border-Gavaskar Trophy and that the selectors are focusing on giving chances to youngsters in the team.

"The way I see it is that, the next T20 World Cup is in 2024, next year, and the new selection committee that has come, wants to give more

opportunities to the younger players. That doesn't mean that Kohli and Rohit won't be considered anymore. And if they have an impressive form throughout 2023 then they have to be in the team. The other factor is with the Australia series starting, the selectors might have wanted to rest them for the big contest so that they can make a fresh start against the Aussies and that will benefit India," Gavaskar said. After featuring in the last T20 World Cup, the duo missed two T20 series India played away from home against New Zealand and Sri Lanka. Both Kohli and Rohit have also not been included in the squad against New Zealand for the T20 series scheduled later this month.

RISHABH PANT LIKELY TO BE DISCHARGED IN TWO WEEKS; REHABILITATION AFTER TWO MONTHS: REPORT

Team India wicket-keeper batsman Rishabh Pant, who has been receiving treatment for injuries sustained in a serious accident in December of last year, is expected to be discharged from the hospital in the coming weeks, according to reports. Pant underwent a successful major surgery on his medial collateral ligament (MCL) and minor repair on his anterior cruciate ligament (ACL), and is making a steady recovery.

A report in The Times of India suggests that Pant is being closely monitored to determine if his ligaments are healing naturally. Once the ligaments have healed, he will begin his rehabilitation process. His progress will be reassessed in two months' time, and he could potentially be ready to play in four to six weeks. The doctors have stated that the MCL surgery was absolutely necessary, and the road to the southpaw's recovery will be arduous.

"The ligaments usually heal in four to six weeks. After that, rehab and strengthening will begin. His return to play will be assessed in another two months. Pant realises that it will be a tough road. He would have to undergo counseling sessions too. It could be four to six months before he can start playing," a BCCI source was quoted as saying to the TOI. Pant sustained lacerations on his forehead, multiple ligament ruptures in his knee, and severe other injuries, including a back abrasion, when his car collided with a divider on the Delhi-Dehradun highway. After several somersaults, the vehicle eventually caught fire as the cricketer was making his way back to his home in Roorkee at around 5:30 in the morning. Pant recently issued a statement, speaking for the first time since the accident saying, "I am humbled and grateful for all the support and good wishes. I am glad to let you know that my surgery was a success. The road to recovery has begun and I am ready for the challenges ahead. Thank you to the @BCCI, @JayShah & government authorities for their incredible support." Rishabh Pant, who made his international cricket debut in February 2017, was part of the triumphant Indian Test squad that secured a 2-0 series victory over Bangladesh in Dhaka in December 2022.

RAFAEL NADAL CRASHES OUT OF **AUSTRALIAN OPEN SECOND ROUND AFTER SUFFERING ANOTHER INJURY ISSUE**



Rafael Nadal's Australian Open title defence came to a whimpering end on Wednesday, as he was defeated 4-6, 4-6, 5-7 by World No. 65 Mackenzie McDonald in the second round. The Spaniard's level was off throughout the first set, when he only made 65% of his first serves, and struggled with both depth and power on his groundstrokes. Midway through the second set, trailing McDonald by a break, Nadal pulled up at the baseline following a rally, clutching his body with a grimacing look on his face. 4-6, 3-5 down, Nadal took a match timeout to get treatment for what appeared to be his hip, and following the long delay, never looked at the same competitive level again. His body language was miserable, as the camera panned to his concerned-looking team, throughout the third set.




